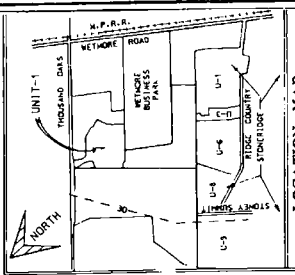

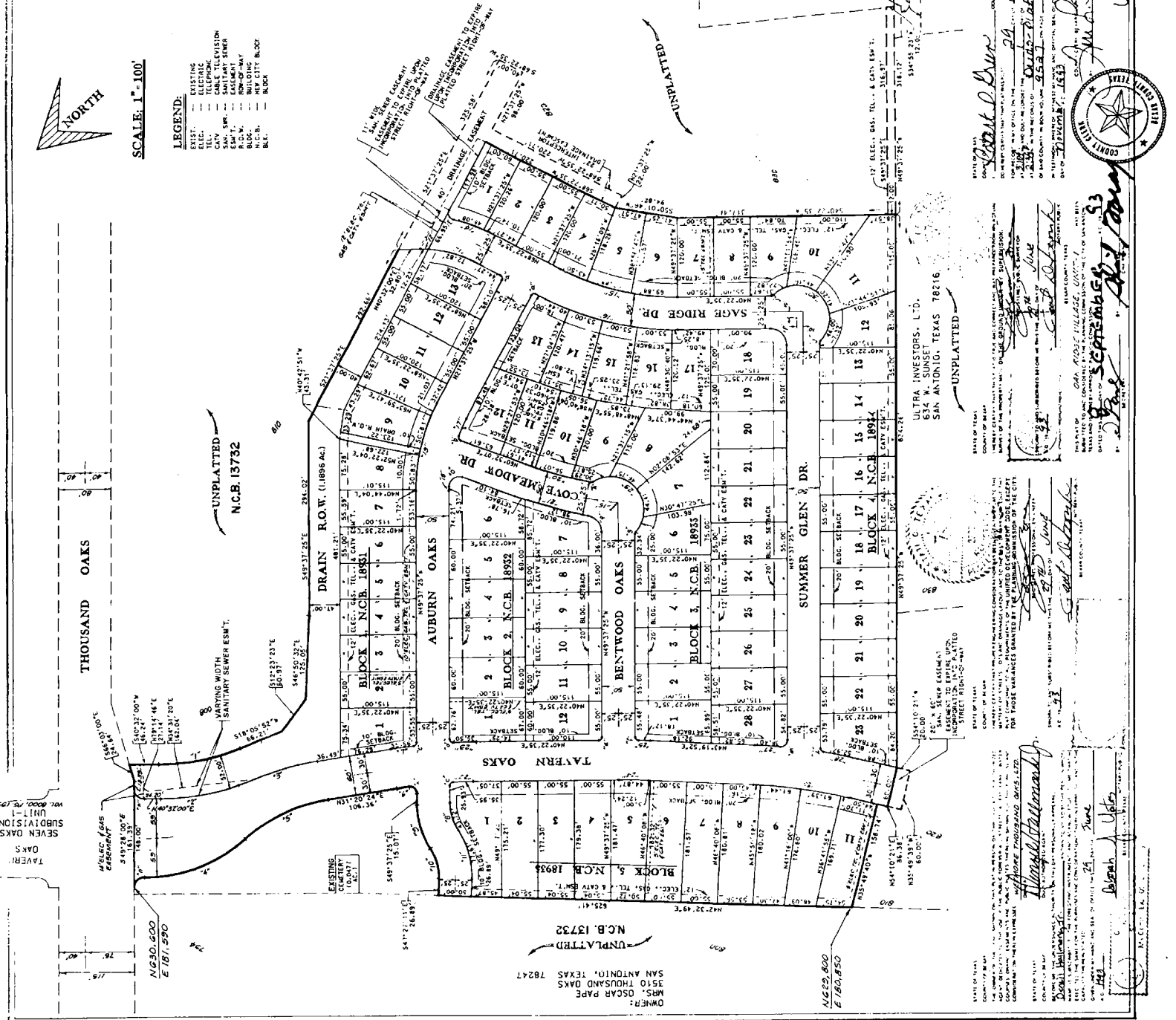
LOCATION MAP
